AMENDMENT TO ARTICLE IV, SECTION 36-41
OF THE EFFINGHAM COUNTY ZONING ORDINANCE

AN ORDINANCE TO AMEND THE CODE OF EFFINGHAM COUNTY, GEORGIA, AS AMENDED, SPECIFICALLY, CODE OF EFFINGHAM COUNTY, GEORGIA ARTICLE IV – OUTDOOR BURNING TO REPEAL CONFLICTING LAWS, ORDINANCES AND RESOLUTIONS, TO PROVIDE SEVERABILITY, AND FOR OTHER PURPOSES

NOW THEREFORE, BE IT ORDAINED BY EFFINGHAM COUNTY BOARD OF COMMISSIONERS AND IT IS HEREBY ORDAINED

Section 1. Amendment. That the Official Code of the County of Effingham, GA, be, and the same hereby is, amended to read as indicated.

NOW THEREFORE, BE IT ORDAINED BY EFFINGHAM COUNTY BOARD OF COMMISSIONERS AND IT IS HEREBY ORDAINED

Section 1. Amendment. That the Official Code of the County of Effingham, GA, be, and the same hereby is, amended to read as indicated.

Sec. 36-41. - Permit required.

- (a) It shall be unlawful for any person, firm, or corporation to set, kindle, maintain, or authorize the setting, kindling, or maintenance of any outdoor fire without first having obtained a permit there for as provided in this article. A permit need not be obtained for campfires for cooking.
- (b) Permits will be issued by the Georgia Forestry office.
- (c) Permits shall be issued for burning only during daylight hours burning Monday—Saturday.
- (d) ~~No burning shall be conducted on Sunday.~~

Section 2. Severability. If any sections, phrase, sentence or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be

deemed a separate, distinct and independent provision, and such holding shall not attest the validity of the remaining portions thereof.


Section 3. Effective Date. This Ordinance shall be effective upon its adoption by the County Commission of the County of Effingham, Georgia.
